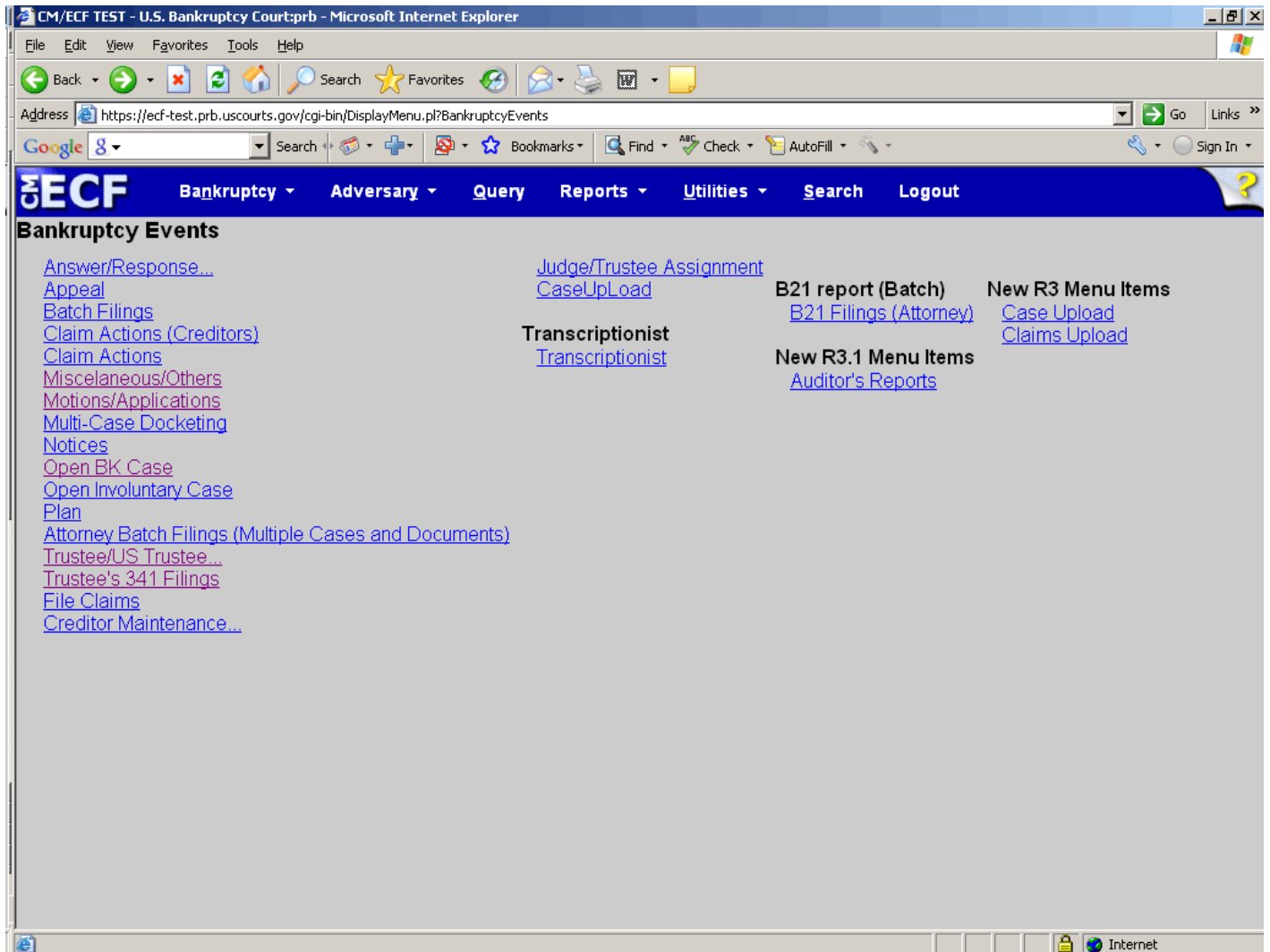
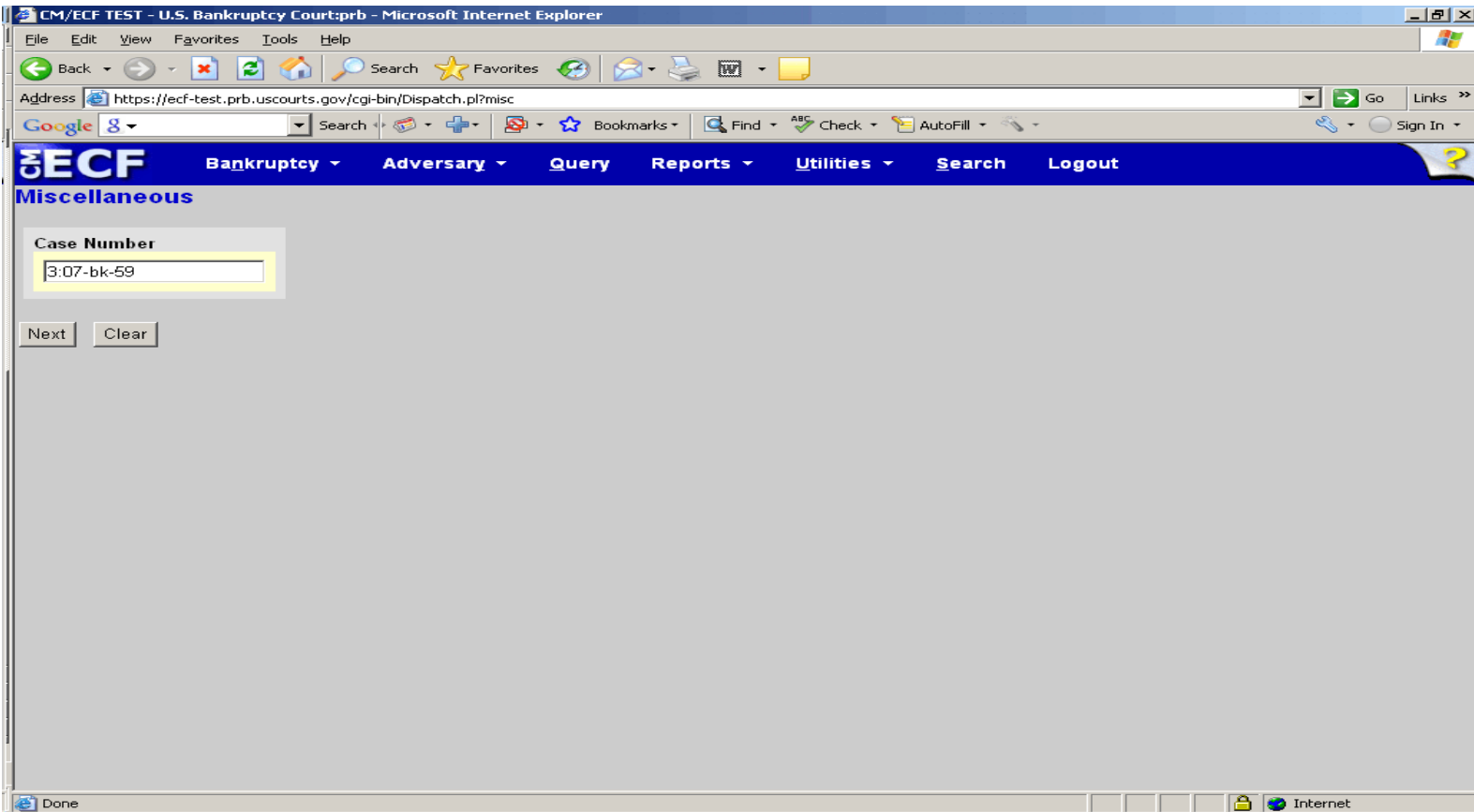


UPDATE EOUST STATS- NEW EVENT INSTUCTIONS
