### **NOTICE TO THE BAR AND TO THE PUBLIC**

#### **COURT MISCELLANEOUS FEE SCHEDULE INCREASES AND CHANGES EFFECTIVE NOVEMBER 1, 2003**

The Judicial Conference, at its September 2003 session, approved an increase in certain miscellaneous fees to account for inflation and rising court costs. In this regard, the Judicial Conference approved several changes to the Bankruptcy Court Miscellaneous Fee Schedule. All changes to the fee schedules, including the Bankruptcy Court Miscellaneous Fee Schedule, will become effective November 1<sup>st</sup>, 2003.

The increases and changes to the Bankruptcy Court Miscellaneous Fee Schedule are as follows:


1. **Document or Paper Certification Fee:** The fee increases from \$7.00 to \$9.00.
2. **Reproduction of Recordings of Proceedings Fee:** The fee increases from \$20.00 to \$26.00.
3. **Amendment Fee:** The fee increases from \$20.00 to \$26.00.
4. **Records Search Fee:** The fee increases from \$20.00 to \$26.00.
5. **Fee for Document Filing or Indexing in a Case or Proceeding for which a Filing Fee has been paid:** The fee increases from \$30.00 to \$39.00.
6. **Miscellaneous Administrative Fee:** The fee increases from \$30.00 to \$39.00.
7. **Microfiche Copy Fee:** The fee increases from \$4.00 to \$5.00.
8. **Record Retrieval Fee:** The fee increases from \$35.00 to \$45.00.

9. **Check Non-Sufficient Funds Fee:** The fee increases from \$35.00 to \$45.00.
10. **Docketing an Appeal:** The fee increases from \$100.00 to \$250.00.
11. **Filing a Motion to Lift Stay:** The fee increases from \$75.00 to \$150.00.
12. **Cross Appeal Docketing Fee:** The fee increases from \$100.00 to \$250.00.

In view of the increase in the administrative fee the filing fees changes as follows:
