**Position Title:** Generalist Clerk

**Job Summary:** Generalist clerks assist the court services team in processing case information and managing the progression of cases from opening to final disposition, in accordance with approved internal controls, procedures and rules. Generalist clerks serve as records and reproductions clerks and/ or case initiation clerks. They receive and review incoming court documents for conformity with federal and local rules, and perform customer service. This position requires traveling to our divisional office located at Ponce, Puerto Rico.

**Minimum Qualifications:** High school graduation or equivalent and two years of general experience. General experience is defined as progressively responsible clerical, office, or other work that indicates the possession of, or the ability to acquire, the particular knowledge and skills needed to perform the duties of the position.

**Educational Substitutions:** Education above the high school level may be substituted for required general experience on the basis of one academic year equals one year of general experience.

**Court Preferred Qualifications:** A Bachelor's Degree from an accredited college or university is preferred. CM/ECF experience is highly desirable as well as experience with WordPerfect, Microsoft Word and Adobe Acrobat.

**Benefits:** Employees appointed under temporary appointments of one year or less are eligible for health insurance coverage, leave, Social Security and Medicare.

**Information for Applicants:** Employees of the judiciary are AT-WILL employees. Applicants must be citizens of the United States of America or be eligible to work in the United States. The selected candidate will be subject to background check and subsequent favorable suitability determination as a condition of employment. The successful applicant will be subject to mandatory electronic transfer of funds for payment of net pay. Only applicants who are interviewed in person will receive a written response regarding their application status. False statements or omissions of information on any application materials may be ground for non-selection. In the event that a position becomes vacant within a reasonable time from the original announcement, the Clerk of Court may elect to select the next top rated candidate from those who applied for the initial announcement without re-posting the position. Selectee will be subject to a six months trial period. The selected candidate may travel frequently to the Southwestern Divisional Office located in Ponce, PR. A valid driver's license is required in order to use the official car. The Court is not authorized to reimburse travel expenses for interviews or relocation.
