ORDER AND NOTICE TO DEBTOR IN POSSESSION

On _____ an order for relief under Chapter 11 of the Bankruptcy Code was entered in the instant case. Notice is hereby given that you must comply with the requirements specified herein below. Failure to comply may constitute cause under 11 USC 1112(b) for the dismissal or conversion to Chapter 7 of the Chapter 11 petition.

1. Debtor shall file the lists, schedules and statements required by Rule 1007 of the Federal Rules of Bankruptcy Procedure within the time limits specified thereunder.

2. Debtor shall appear and submit to examination under oath at the meeting of creditors under Section 341(a), 11 USC 341(a).

3. The debtor shall file a reorganization plan and disclosure statement within 180 days from the date of filing the Chapter 11 petition. A request to extend the period must be filed at least thirty (30) days prior to the expiration of the time limit. The Court will only extend the period upon a timely application and for cause plead with sufficient specificity.

4. The debtor shall file an original monthly report with the Clerk of the Bankruptcy Court, and shall serve a copy upon

1 the U.S. Trustee. The monthly reports shall be in the form
2 specified by the U.S. Trustee. Monthly reports are on a
3 calendar month basis and shall be filed by the twentieth (20th)
4 day of the month following the month reported on.

5 5. The debtor shall pay the quarterly fees to the U.S.
6 Trustee no later than one month following the end of each
7 calendar quarter.
