## Notice to the Bar and the Public



Please take notice that our court has an established practice to assign related cases to the same judge. It is impossible for the Clerk's Office to perform its duty and ensure the correct judge assignment from the inception of the case, as it is expected, if the related case(s) information is missing from the petition. Furthermore, delay and last minute judges' reassignment of a case negatively affects its case management, and causes loss of time for all parties involved.

Effective immediately attorneys are instructed to clearly state information of any related case in page 2 of the voluntary petition (see attachment). If the cases are filed at the same time, fill out only the debtor's name, district, and the relationship information. In addition, please notify the clerk's office by email at [relatedcases@prb.uscourts.gov](mailto:relatedcases@prb.uscourts.gov). Strict compliance with this notice is required.
