
Notice to the Bar and the Public

In Re: New On-line Report to Access “Notices of Intent to Sell Property at Public Sale”

A new on-line report is available in our court’s website for the public to access all of the Notices of Intent to Sell at a Public Auction filed by the Chapter 7 trustees. This report reflects all of the notices filed via CM/ECF. The public may also have access to the notice itself by clicking on the “main document” link. The report is located on the left hand side in our website under Report Notices of Intent to Sell.

Chapter 7 trustees should further note that the “*Notice of Intent to Sell-Public*” event located under Trustee/US Trustee/ Trustee Ch. 7 Menu in CM/ECF has been modified. The event now requires information as follows: *Property Description*, *Auction Date* and *Location* in addition to the objection language.
