## Notice to the Bar and the Public

---

**In Re: CORONAVIRUS AID, RELIEF AND ECONOMIC SECURITY ACT BANKRUPTCY  
PROVISION EXPIRATION DUE ON MARCH 27, 2022**

On March 27, 2020, The President signed into law the Coronavirus Aid, Relief and Economic Security (CARES) Act. On March 27, 2021, the President signed into law an *amended* version of the Act which extended the provisions in section 1113 of the CARES Act for one year. Therefore, the provisions expired on March 27, 2022.


Under the CARES Act, the temporary amendments were made to Official Forms 101, 122A-1, 122B, 122C- 1, and 201 (the CARES Act amendments). As a result of the sunset of the CARES Act, the temporary amendments to the Official forms will revert to the pre-CARES Act versions on **March 28, 2022** as follows:

- Official Form 101, Voluntary Petition for Individuals Filing for Bankruptcy (reverts to prior version of line 13);
- Official Form 201, Voluntary Petition for Non-Individuals Filing for Bankruptcy (reverts to prior version of line 8);
- Official Form 122A-1, Chapter 7 Statement of Your Current Monthly Income (reverts to prior version of line 10);
- Official Form 122B, Chapter 11 Statement of Your Current Monthly Income (reverts to prior version of line 10);
- Official Form 122C-1, Chapter 13 Statement of Your Current Monthly Income and Calculation of Commitment Period (reverts to prior version of line 10);

These changes are in addition to the changes described in the March 11 2022, Notice to the BAR and the Public 22-07 ("[In Re: Automatic Adjustment of Certain Dollar Amounts in the Bankruptcy Code, Title 28, and Official and Director's Bankruptcy Forms, Effective April 1, 2022](#)") which will become effective April 1, 2022.
