**CHANGE IN TRANSCRIPT FEE RATES AND  
RENAMED TRANSCRIPT DELIVERY CATEGORIES**

The Judicial Conference of the United States Courts approved two increases to the maximum per page original and copy transcript fee rates and modified the transcript category names to clarify delivery timing and avoid confusion regarding applicable costs.

Transcripts ordered prior to October 1, 2023, should be billed at the rates in effect at the time the order was placed with the official court reporter.

The new rates and transcript category names are listed in the tables below:



<b>3-Day Transcript (No change)</b> A transcript to be delivered within three (3) calendar days after receipt of an order.	\$6.00	\$6.55
<b>Next-Day Transcript (Daily)</b> A transcript to be delivered on the calendar day following receipt of the order (regardless of whether that calendar day is a weekend or holiday), prior to the normal opening hour of the clerk's office.	\$6.70	\$7.30
<b>2-Hour Transcript (Hourly)</b> A transcript of proceedings to be delivered within two (2) hours from receipt of the order.	\$8.00	\$8.70
<b>Realtime Transcript (No change)</b> A draft unedited transcript produced by a certified realtime reporter as a byproduct of realtime to be delivered electronically during proceedings or immediately following receipt of the order.	One feed, \$3.40; two-to- four feeds, \$2.35; five or more feeds, \$1.65.	One feed, \$3.70; two-to- four feeds, \$2.55; five or more feeds, \$1.80.
