

**CHANGES TO THE MISCELLANEOUS FEE SCHEDULES**  
**EFFECTIVE DECEMBER 1, 2023**

At its March 2023 and September 2023 sessions, on the recommendation of the Committee on Court Administration and Case Management, the Judicial Conference approved inflationary adjustments to fees on the appellate, district, and bankruptcy court miscellaneous fee schedules, as well as on the Court of Federal Claims and the Judicial Panel on Multidistrict Litigation miscellaneous fee schedules.

Changes to the above-referenced miscellaneous fee schedules will take effect December 1, 2023. The chart included as attachment details the increased amounts for the Bankruptcy Miscellaneous Fee Schedule.
